



## Wallace State Community College Department of Nursing Education Program Information/Application Packet

(PLEASE READ ENTIRE PACKET CAREFULLY)

Dear Prospective Student:

Thank you for your interest in the Nursing Education Department at Wallace State Community College. Enclosed you will find the information you requested.

**The Associate Degree Program accepts a class each Fall and Spring Semester.** The following information details the admission criteria for the **Associate Degree (RN)** program:

1. Unconditional admission to the college – **WSCC application must be submitted to the Office of Admissions by the nursing application deadline.**
2. Receipt of completed nursing application between **February 15 and April 15 for *Fall* entry** **OR** between **July 1 and September 1 for *Spring* entry.**
3. A minimum GPA of 2.5 on a 4.0 scale based on the most recent 24 credit hours for students *with* previous college coursework is required. **Official transcripts from each college attended must be provided to the WSCC Admissions Office by the nursing application deadline. Unofficial transcripts from each college must be attached to the nursing application.**
4. A minimum cumulative GPA of 2.5 on a 4.0 scale *from high school* for students *without* previous college coursework is required. Official high school transcripts must be provided to the Office of Admissions by the nursing application deadline (GED accepted). **High school transcript (unofficial accepted) must be attached to the nursing application for review of possible point classes, if applicable.**
5. Student must be eligible for:
  - a. Math 100 (Intermediate College Algebra) as determined by college policy, and
  - b. BIO 201 (A & P I) during the first term of nursing courses.  
\*(BIO 103 is the pre-requisite to BIO 201; the ACCS placement exam is available for BIO 103.)
6. Student must be in good standing with the college.
7. Student must meet the Essential Functions and technical standards required for nursing (available at [www.wallacestate.edu/nursing](http://www.wallacestate.edu/nursing) - see Physical Form Essential Functions).
8. **Test of Essential Academic Skills-Version Five (TEAS-V)** is utilized for nursing entry. This test measures basic essential skills in the academic content area of reading, math, science, and English and language usage. Go to [www.atitesting.com](http://www.atitesting.com) for more information on the TEAS-V exam and to register.

Admission to the Associate Degree Nursing Program is competitive; the number of students is limited by the number of faculty and clinical facilities available. **Meeting minimal requirements does not guarantee acceptance.** After meeting all requirements, applicants are rank-ordered using a point system based on TEAS-V score, points from selected college (BIO 201, BIO 202, BIO 220) *and/or* high school courses (Algebra II, highest level Biology, Chemistry). Point schema: A=30; B=20; C=10.

**Mobility students are accepted once per year in the Spring Semester.** Mobility students must meet admission criteria to WSCC for the Associate Degree (RN) program (see above). Licensed Practical Nurses are admitted with advanced standing into the ADN Mobility program and follow the curriculum as outlined:

LPN's will be required to successfully complete NUR 200 (Nursing Career Mobility Assessment) prior to integration into the nursing program in order to validate the theoretical knowledge and clinical skill level consistent with students progressing to the third semester of the ADN curriculum. Students who successfully complete this course are awarded 15 non-traditional hours at the completion of the LPN mobility curriculum.

**NUR 200 will be waived for LPNs who are admitted to the Mobility program within two years of graduation from the new Alabama College System Standardized Practical Nursing Curriculum implemented in Fall 2005. For progression into NUR 201, students must have documentation of employment as an LPN for a minimum of 500 clock hours within the 12 months prior to admission.**

Unless previously completed, ENG 101 and BIO 202 must be taken concurrently with NUR 200 **during the spring semester of the Mobility curriculum** as well (**also applies to LPNs for whom NUR 200 is waived**). Upon successful completion of the Mobility requirements, the student will follow the regular ADN curriculum outline beginning in the third semester for the remainder of the program.

**The Practical Nursing Program accepts a class in the Fall Semester each year.** The following information details the admission requirements for the **Practical Nursing (PN)** program:

1. Unconditional admission to the college – **WSCC application must be submitted to the Office of Admissions by the nursing application deadline.**
2. Receipt of completed nursing application between **February 15 and April 15 for Fall entry only.**
3. A minimum GPA of 2.5 on a 4.0 scale based on the most recent 24 credit hours for students *with* previous college coursework is required. **Official transcripts from each college attended must be provided to the WSCC Admissions Office by the nursing application deadline. Unofficial transcripts from each college must be attached to the nursing application.**
4. A minimum cumulative GPA of 2.5 on a 4.0 scale *from high school* for students *without* previous college coursework is required. Official high school transcripts must be provided to the Office of Admissions by the nursing application deadline (GED accepted). **High school transcript (unofficial accepted) must be attached to the nursing application for review of possible point classes, if applicable.**
5. Student must be eligible for:
  - a. Math 116 as determined by college policy, and
  - b. BIO 201 (A & P I) during the first term of nursing courses.  
\*(BIO 103 is the pre-requisite to BIO 201; the ACCS placement exam is available for BIO 103.)
6. Student must be in good standing with the college.
7. Student must meet the essential functions and technical standards required for nursing (available at [www.wallacestate.edu/nursing](http://www.wallacestate.edu/nursing) - see Physical Form Essential Functions).
8. **Test of Essential Academic Skills-Version Five (TEAS-V)** is utilized for nursing entry. This test measures basic essential skills in the academic content area of reading, math, science, and English and language usage. Go to [www.atitest.com](http://www.atitest.com) for more information on the TEAS-V exam and to register.

Admission to the Practical Nursing Program is competitive; the number of students is limited by the number of faculty and clinical facilities available. **Meeting minimal requirements does not guarantee acceptance.** After meeting all requirements, applicants are rank-ordered using a point system based on the TEAS-V score, points from selected college (ENG 101, MTH 116) and/or high school courses, if no college coursework has been completed (Algebra II, highest level Biology). Point schema: A=30; B=20; C=10.

We have enclosed an anticipated expense sheet to assist you with estimated expenses that will be incurred during the nursing program. These are only estimates; expenses may vary from semester to semester.

**\*STANDARDIZED TESTS**

The Department of Nursing Education requires students to participate in a standardized testing program to assist in evaluating achievement of the content of the courses throughout the curriculum. Included in this testing program are:

1. Examinations to evaluate areas that are essential for academic success.
2. Diagnostic and Achievement Tests help to identify your strengths and areas which need remediation in comprehending the content of the courses.
3. Pre-RN/PN Examination (mock licensure exam) provides reliable predictors of success for the NCLEX exam.
4. Specific examinations may be required as a part of progression in identified nursing courses.

## NOTES REGARDING PHYSICAL EXAMINATION

A physical exam is required upon acceptance into the nursing program. A qualified health care provider (physician or certified nurse practitioner only) must perform the physical examination and record his/her findings on the official physical form. **The physical must be performed after August 1 of the year in which you are accepted into the FALL nursing program and is due no later than September 1; the physical must be performed after December 1 of the year in which you are accepted into the SPRING nursing program and is due no later than January 8.** Any sections not completed will result in the physical exam being rejected and may result in delay of progression in the program. **Appropriate signatures, address and phone number of the health care provider must be on the form.** Authenticity of the form may be verified by the Department of Nursing Education. Other forms (i.e., company physical or health screenings) are **NOT** accepted in lieu of the Department of Nursing Education form.

Immunization history must be complete and accurate. Simply stating that you had measles, mumps, etc. “during childhood” is not adequate. Physician’s documentation, i.e. lab report or immunization/titer is required.

<b><u>TB Test</u></b>	Mantoux type skin test with date and results. The Tine TB test is <b>NOT ACCEPTABLE</b> . <b>If you have had a TB skin test within the past year, you are not required to complete a two-step TB test; a single TB skin test is sufficient. (You must provide documentation of the TB skin test taken within the last year.)</b>
<b><u>Chest X-ray</u></b>	Only required as a follow-up to a positive skin test, or in lieu of a skin test for TB for those who have had an allergic reaction to the test in the past. <b>(Provide written documentation of X-ray results; not the actual X-ray.)</b>
<b><u>Measles (Rubeola)</u></b>	If documentation of vaccination is not available, an IGG/IGM titer (blood test) verifying proof of immunity is required. An alternative to the titer is another vaccination. Documentation of the vaccination or titer exhibiting immunity is required.
<b><u>Rubella</u></b>	Proof of immunization or titer is required as above.
<b><u>Mumps</u></b>	Proof of immunization or titer is required as above.
<b><u>Chickenpox</u></b>	Proof of immunization or titer is required as above.
<b><u>Tetanus</u></b>	Proof of immunization within the last 10 years.
<b><u>Hepatitis B</u></b>	The three-part series for Hepatitis B immunization is strongly encouraged. In the absence of the series, students must sign a waiver acknowledging the risks of exposure to hepatitis. Some clinical agencies may require the series, thus limiting clinical options for students who choose to waive the immunization. Proof of a positive Hepatitis B titer (specifically the antibody to the Hepatitis B surface antigen) may be substituted in lieu of the Hepatitis B vaccine.

**NOTE:** Pregnant or lactating females or students with chronic illnesses, which may make the immunizations ill-advised, must have supporting documentation by the approved health-care provider. Pregnant/lactating females should provide anticipated date when eligible to receive the vaccinations.

Health-care providers (including students) who are positive for HIV or Hepatitis must submit a statement to the State Department of Public Health in Montgomery, and abide by their guidelines regarding direct patient contact. See Student Handbook for complete information about the Infected Health Care Worker Act.

## **For Applicants Information:**

The Alabama Board of Nursing will require that you answer the following questions when you apply to take the licensure examination at the conclusion of your program of study.

***Eligibility to take the examination is the decision of the ABN; graduation from an accredited school such as WSCC does not ensure eligibility.***

1. Have you ever been arrested for, been charged with, been convicted of, entered a plea of guilty to, entered a plea of nolo contendere or no contest for, received deferred prosecution or adjudication for, had judgment withheld for, received pretrial diversion for, or pleaded not guilty by reason of insanity or mental defect to any crime other than a minor traffic violation in any state, territory, or country? A crime related to driving while impaired or while under the influence of any substance is not a “minor traffic violation.”
2. In the past five years, have you abused alcohol, drugs (whether legal or illegal, prescribed or unauthorized), and/or other chemical substances or received treatment or been recommended for treatment for dependency to alcohol, drugs (whether legal or illegal, prescribed or unauthorized), and/or other chemical substances?
3. Have you ever been arrested or convicted for driving under the influence of drugs/alcohol?
4. In the past five years, have you had, or do you now have, a physical or mental health problem that may impair your ability to provide safe nursing care?
5. Has the licensing authority of any state, territory, or country denied, revoked, suspended, reprimanded, fined, accepted your surrender of, restricted, limited, placed on probation, or in any other way disciplined your nursing and/or any other occupational license, registration, certification, or approval?
6. Is the Board of Nursing or other licensing authority of any state, territory, or country, including but not limited to the Alabama Board of Nursing, currently investigating you?
7. Is disciplinary action pending against you with the Board of Nursing or other licensing authority of any state, territory, or country, including but not limited to the Alabama Board of Nursing?
8. Have you ever been placed on a state and/or federal abuse registry?
9. Has any branch of the armed services ever administratively discharged you with any characterization of service besides “Honorable” and/or court-martialed you?

- 5. Eligibility for English 101 and Math 100 (Intermediate College Algebra) for AD applicants *OR* Math 116 for PN applicants (higher level math accepted).**
- 6. Eligibility for BIO 201 during the first term of Associate Degree Nursing and Practical Nursing.**
- 7. Good standing with college.**
- 8. Meeting the essential functions or technical standards required for nursing.**
- 9. The Test of Essential Academic Skills-Version Five (TEAS-V) taken *within the past three years*.**

**NOTE:** The following must be on file in Admissions by *April 15 for fall entry OR September 1 for Spring entry*:

- 1) College Application;**
- 2) All Official College transcripts;**
- 3) Official High School transcripts (must be on file in the Admission's Office in order to utilize possible HS points).**

It is recommended that you check with the Admission's Office to verify that your file is complete prior to the nursing application deadline.

*This application must be submitted to the Nursing Department by the published deadline with all college transcripts attached (unofficial accepted). Additionally, a high school transcript must also be attached in order to utilize possible high school point classes for nursing entry (unofficial accepted).*

## **THE ALABAMA COLLEGE SYSTEM NURSING PROGRAMS ESSENTIAL FUNCTIONS**

The Alabama College System endorses the Americans' with Disabilities Act. In accordance with College policy, when requested, reasonable accommodations may be provided for individuals with disabilities.

Physical, cognitive, psychomotor, affective and social abilities are required in unique combinations to provide safe and effective nursing care. The applicant/student must be able to meet the essential functions with or without reasonable accommodations throughout the program of learning. Admission, progression and graduation are contingent upon one's ability to demonstrate the essential functions delineated for the nursing programs with or without reasonable accommodations. The nursing programs and/or its affiliated clinical agencies may identify additional essential functions. The nursing programs reserve the right to amend the essential functions as deemed necessary.

In order to be admitted and to progress in the nursing program one must possess a functional level of ability to perform the duties required of a nurse. Admission or progression may be denied if a student is unable to demonstrate the essential functions with or without reasonable accommodations.

The essential functions delineated are those deemed necessary the Alabama College System nursing programs. No representation regarding industrial standards is implied. Similarly, any reasonable accommodations made will be determined and applied to the respective nursing program and may vary from reasonable accommodations made by healthcare employers.

The essential functions delineated below are necessary for nursing program admission, progression and graduation and for the provision of safe and effective nursing care. The essential functions include but are not limited to the ability to:

- 1) Sensory Perception
  - a) Visual
    - i) Observe and discern subtle changes in physical conditions and the environment
    - ii) Visualize different color spectrums and color changes
    - iii) Read fine print in varying levels of light
    - iv) Read for prolonged periods of time
    - v) Read cursive writing
    - vi) Read at varying distances
    - vii) Read data/information displayed on monitors/equipment
  - b) Auditory
    - i) Interpret monitoring devices
    - ii) Distinguish muffled sounds heard through a stethoscope
    - iii) Hear and discriminate high and low frequency sounds produced by the body and the environment
    - iv) Effectively hear to communicate with others
  - c) Tactile
    - i) Discern tremors, vibrations, pulses, textures, temperature, shapes, size, location and other physical characteristics
  - d) Olfactory
    - i) Detect body odors and odors in the environment
- 2) Communication/ Interpersonal Relationships
  - a) Verbally and in writing, engage in a two-way communication and interact effectively with others, from a variety of social, emotional, cultural and intellectual backgrounds
  - b) Work effectively in groups
  - c) Work effectively independently
  - d) Discern and interpret nonverbal communication
  - e) Express one's ideas and feelings clearly
  - f) Communicate with others accurately in a timely manner
  - g) Obtain communications from a computer
- 3) Cognitive/Critical Thinking
  - a) Effectively read, write and comprehend the English language
  - b) Consistently and dependably engage in the process of critical thinking in order to formulate and implement safe and ethical nursing decisions in a variety of health care settings
  - c) Demonstrate satisfactory performance on written examinations including mathematical computations without a calculator
  - d) Satisfactorily achieve the program objectives

### Motor Function

- h) Handle small delicate equipment/objects without extraneous movement, contamination or destruction
- i) Move, position, turn, transfer, assist with lifting or lift and carry clients without injury to clients, self or others
- j) Maintain balance from any position
- k) Stand on both legs
- l) Coordinate hand/eye movements
- m) Push/pull heavy objects without injury to client, self or others
- n) Stand, bend, walk and/or sit for 6-12 hours in a clinical setting performing physical activities requiring energy without jeopardizing the safety of the client, self or others
- o) Walk without a cane, walker or crutches
- p) Function with hands free for nursing care and transporting items
- q) Transport self and client without the use of electrical devices
- r) Flex, abduct and rotate all joints freely
- s) Respond rapidly to emergency situations
- t) Maneuver in small areas
- u) Perform daily care functions for the client
- v) Coordinate fine and gross motor hand movements to provide safe effective nursing care
- w) Calibrate/use equipment
- x) Execute movement required to provide nursing care in all health care settings
- y) Perform CPR and physical assessment
- z) Operate a computer

### 3) Professional Behavior

- a) Convey caring, respect, sensitivity, tact, compassion, empathy, tolerance and a healthy attitude toward others
- b) Demonstrate a mentally healthy attitude that is age appropriate in relationship to the client
- c) Handle multiple tasks concurrently
- d) Perform safe, effective nursing care for clients in a caring context
- e) Understand and follow the policies and procedures of the College and clinical agencies
- f) Understand the consequences of violating the student code of conduct
- g) Understand that posing a direct threat to others is unacceptable and subjects one to discipline
- h) Meet qualifications for licensure by examination as stipulated by the Alabama Board of Nursing
- i) Not to pose a threat to self or others
- j) Function effectively in situations of uncertainty and stress inherent in providing nursing care
- k) Adapt to changing environments and situations
- l) Remain free of chemical dependency
- m) Report promptly to clinicals and remain for 6-12 hours on the clinical unit
- n) Provide nursing care in an appropriate time frame
- o) Accepts responsibility, accountability, and ownership of one's actions
- p) Seek supervision/consultation in a timely manner
- q) Examine and modify one's own behavior when it interferes with nursing care or learning

Upon admission, an individual who discloses a disability can request reasonable accommodations. Individuals will be asked to provide documentation of the disability in order to assist with the provision of appropriate reasonable accommodations. The respective College will provide reasonable accommodations but is not required to substantially alter the requirements or nature of the program or provide accommodations that inflict an undue burden on the respective College. In order to be admitted one must be able to perform all of the essential functions with or without reasonable accommodations. If an individual's health changes during the program of learning, so that the essential functions cannot be met with or without reasonable accommodations, the student will be withdrawn from the nursing program. The nursing faculty reserves the right at any time to require an additional medical examination at the student's expense in order to assist with the evaluation of the student's ability to perform the essential functions.
